#### **Focus**

The 2030 Agenda for Sustainable Development and its 17 Sustainable Development Goals (SDGs) provide us with a shared vision of "what" we want for the future. However, "how" will we reach this vision? How can we improve global sustainability governance to deliver the 2030 Agenda and the SDGs? How can we be better prepared for future challenges? How should we go beyond the 2030 Agenda and what future reforms are necessary?

These are questions we aim to reflect upon during the Utrecht Summer School on "The Future of Sustainability Governance". The Summer School will take place on 26-30 August in Utrecht, the Netherlands. In the first three days, the Summer School will offer a combination of lectures, workshops and practical experience. On August 29 and 30, participants will take part in the international research conference GLOBALGOALS2024—*The Future of the SDGs*,

#### **Format**

The Utrecht Summer School, organized by the GLOBALGOALS Project based at Utrecht University, brings together a team of scholars dedicated to research, teaching and action in sustainability governance. It offers academic lectures, practical research skills and experiences with SDG implementation, building expertise on the state of play of the current sustainable development discussions.

It provides an environment conducive to knowledge sharing on challenging issues in global sustainability governance. In addition to being a learning space, it is an opportunity for network building in the context of the GLOBALGOALS2024 conference. Further, it enables participants to advance in their academic skills, including writing, presenting, reviewing, and publishing.

The following formats will be used during the Summer School:

#### 1. Lectures & Dialogue

There are four Lecture & Dialogues with sustainability governance scholars. The focus of the sessions is on interaction and ample time for discussion will be provided.

## 2. World Café & Lightning Talks

There will be one World Café and various Lightning Talks during the Summer School. The World Café methodology uses an informal setting for participants to explore an issue by discussing it in small groups, during multiple rounds. The focus is on enabling an open conversation between the participants and senior scholars.

#### 3. Writeshops

The writeshops focus on participants' own work. The aim of the writeshops is to take initial ideas forward into concrete projects and publications. We work in small groups of people whose work addresses similar themes, combining short exercises with intensive writing and peer review sessions. At the end of the Summer School, participants will have an improved piece of written work to take home.

#### 4. Futures Thinking

Summer School participants will jointly prepare research contributions and provide recommendations for the future of sustainability governance, during "futures thinking" sessions. A representative will present these recommendations at GLOB-ALGOALS2024—The Future of the SDGs,

## Short speaker biography

Frank Biermann is the co-chair of the GLOBALGOALS2024 conference. He is a Professor of Global Sustainability Governance at Utrecht University, The Netherlands, where he directs the GLOBALGOALS Project, a €2.5 million research programme on the Sustainable Development Goals, funded by a European Research Council Advanced Grant. Previously, he was the founding chair of the Earth System Governance Project, a global research network. Biermann has authored or edited 20 books and published over 200 articles and book chapters on global governance and sustainability. He edits the Earth System Governance journal and two book series with MIT Press and Cambridge University Press. Biermann has

received numerous awards, including the 2021 Distinguished Scholar Award in Environmental Studies of the International Studies Association.

## **Imagination and Scientific Writing for Sustainability**

Joost Vervoort, Associate Professor, Utrecht University

What is the role of imagination in sustainability governance? How can using imagination help us in academic writing to enhance greater social impact? This lecture will look into the possibilities of applying the technique of imagination to improve your writing skills.

## Short speaker biography

Joost Vervoort is Associate Professor of Transformative Imagination in the Environmental Governance Group at the Copernicus Institute of Sustainable Development; an Honorary Research Associate at the Environmental Change Institute, University of Oxford; and a Visiting Fellow at the Research Institute for Humanity and Nature in Kyoto, Japan. Joost's research focuses on how different imaginations of the future connect to action in the present. Seeking to break through the limits of current ways of working with the future, Joost is currently focusing on two connected research interests: 1. Using games and creative practices to help create more imaginative societies for better futures; and 2. The politics of foresight.

## **Envisioning Sustainability Governance post-2030**

This Futures Thinking workshop is focused on visioning, a foresight method that attempts to create feasible and desirable future scenarios in which current problems are solved. Visioning answers the question WHAT... What is my/our desired future for sustainability governance? What does it look like? You are expected to bring an image (postcard size) of their desired future. The session starts with a group discussion on the images. The output of the session is a collectively created vision board with images and keywords, representing the group's desired future for sustainability governance.

## Short speaker biography

Fronika de Wit is a postdoctoral researcher at the Copernicus Institute of Sustainable Development at Utrecht University, The Netherlands, conducting research on (global) sustainability governance and the future of the SDGs. She has vast experience working on the

science-policy-society interface in various countries, which have provided her with a transdisciplinary and intercultural perspective on sustainability governance. Amongst others, she worked at the Portuguese Centre of Government, coordinating Science for Policy projects and working with participatory futures thinking. She holds a PhD in climate change and sustainable development policies from the University of Lisbon, Portugal. In 2023, she was awarded the Oran R. Young Prize, which rewards cutting-edge research on earth system governance by early-career scholars.

## Barriers and Opportunities for Transdisciplinarity of Sustainability Governance and Research

Marjanneke Vijge, Associate Professor, Utrecht University

How can transdisciplinarity improve sustainability governance and research? What should be taken into account? This lecture and dialogue provide best practices and lessons learned for transdisciplinary collaborations in governing sustainability challenges.

#### Short speaker biography

Marjanneke J. Vijge is Associate Professor at the Copernicus Institute of Sustainable Development, Utrecht University. Her work focuses on multilevel governance of trade-offs between sustainability goals and social justice in Africa, Asia and Europe. She has expertise in policy coherence around the Sustainable Development Goals and climate goals, among others in the fields of climate and food security. At Utrecht University, Marjanneke is Academic Director of CHARM-EU and Programme Leader of the joint European Master's programme 'Global Challenges for Sustainability' that she helped develop. CHARM-EU is a European Universities Initiative funded by the European Commission. CHARM-EU serves as a testbed for innovations in challenge-based and transdisciplinary education and research around sustainability.

During this World Café, senior scholars share their general advice on academic skills in the field of global sustainability governance and things they wish they had known earlier in their career. The World Café starts with short introductions by the speakers, followed by three rounds of interactive discussions on: 1. Academic writing and publishing; 2. Project design and funding and 3. Communication and Engagement. Group moderators will write down up to three take-aways from every round.

## Short speaker biographies

Carole-Anne Sénit is Assistant Professor of Inclusive Sustainability Governance with the Copernicus Institute of Sustainable Development at Utrecht University, The Netherlands. She is a political scientist by training, with a career spanning both research on and practice in the civil society sector. Her research explores the integration of the Global South within global change science, global civil society, and global institutions. She is a senior research fellow of the Earth System Governance Project, co-convenor of the Project's taskforce on the Sustainable Development Goals and managing editor of the Earth System Governance journal.

Thomas Hickmann is an Associate Professor at the Department of Political Science of Lund University in Sweden. His research is concerned with the question of how societies can adequately deal with global common goods and which institutions need to be in place to overcome problems such as biodiversity loss, climate change and land degradation. Hickmann has published in prestigious academic journals including Ambio, International

Studies Review and Nature Sustainability. His most recent co-edited book published with Cambridge University Press brought together 61 experts from all over the world to assess the political impact of the Sustainable Development Goals.

Rakhyun (Rak) Kim is Associate Professor of Earth System Governance at the Copernicus Institute of Sustainable Development at Utrecht University in the Netherlands. He directs a five-year research project on 'problem shifting' between international environmental treaties, supported by a Starting Grant from the European Research Council. He is an interdisciplinary social scientist at the intersection of global environmental governance and international environmental law and works on theories of Earth system-oriented, postglobal, planetary law and governance. Analytically, his research interests include exploring the complexity and dynamics of institutional architectures, with a focus on international regimes, agreements, and organizations as key building blocks. He has authored more than 80 publications in journals and books.

## Participation in global sustainability governance

Who participates in global sustainability governance and how? This lecture and dialogue will critically examine the way Major Groups and Other Stakeholders were involved in the development and implementation of Agenda 2030. In this lecture and dialogue, we will look back at the creation of the Major Groups and Other Stakeholders, review how they contribute to sustainability governance, and discuss their challenges with a case study on youth participation.

## Short speaker biographies

Mara Wendebourg is a postdoctoral researcher at the Copernicus Institute of Sustainable Development at Utrecht University. For her PhD at King's College London, Mara examined the role of scientific advisory bodies in law-making through the study of norm diffusion. During her doctoral research, Mara also volunteered at the Advisory Committee on the Protection of the Sea, following meetings of the Marine Environmental Protection Committee of the International Maritime Organization. Prior to that, Mara was a trainee at the European Commission and interned at the International Seabed Authority. She holds an LLM in Public International Law from Utrecht University and an MSc in Marine Systems and Policies at the University of Edinburgh.

Yi hyun Kang is a postdoctoral researcher at the Department of Political Science at Lund University, Sweden. Her research explores the governance, network and discursive aspects of climate, biodiversity and sustainable development politics at the global level, with a special focus on the role of civil society and technology. Previously, she was a postdoctoral researcher at UCLouvain Saint-Louis Bruxelles, carrying out a project on youth participation in global environmental politics. She received her PhD from the Technical University of Munich with her dissertation on climate change adaptation policies of South Korea and Germany.

#### Short speaker biographies

Pamela Chasek is a Professor of Political Science at Manhattan College, United States, and the co-founder and executive editor of the Earth Negotiations Bulletin, a reporting service on UN environment and development negotiations. She has written about and followed UN environment and sustainable development negotiations for over 32 years. Chasek is the author and editor of numerous articles and books, including Transforming Multilateral Diplomacy: The Inside Story of the Sustainable Development Goals, Earth Negotiations, and Global Environmental Politics. She has served as a consultant to the UNCCD, the UN Environment Management Group, UNEP, UNDP, UN Forum on Forests, and the UN Department of Economic and Social Affairs.

Dan Banik is Professor of Political Science, Director of the Oslo SDG Initiative at the Centre for Development and the Environment, and Affiliate Professor at Faculty of Medicine, University of Oslo, Norway. He is also Academic Director of the Democracy Hub at Circle U. European University Alliance and Extraordinary Professor at the University of Pretoria. His books include Political Transition, Poverty, and Inclusive Development in Malawi: The Democratic Dividend; Poverty and Elusive Development; and Starvation and India's Democracy. Banik was a Visiting Professor and Consulting Scholar at Stanford University (2010- 2017) and a Visiting Professor at China Agricultural University (2012-2017). He is the host of the In Pursuit of Development podcast with listeners in 160 countries.

*Margarita Gómez* is the Executive Director of Southern Voice, a network of 70 thinktanks from Africa, Latin America and Caribbean, and Asia. Previously, Gómez founded and led two policy-impact innovation centres, the People in Government Lab at the Blavatnik School of Government at Oxford University, United Kingdom, and the Behavioural Unit at

CIDE in Mexico. She was also an advisor to Mexico's Public Security and Defence Ministers. Gómez has more than 15 years of experience working with governments, international organizations and world-class universities, delivering context and policy-relevant research. Her research focuses on financial and gender inclusion, integrity and ethics in governments, public security, and public sector transformation. She is a Visiting Fellow at the Blavatnik School of Government at Oxford, a Senior Research Fellow at the Public Management and Innovation Lab, and a Behavioural Advisor at the Asian Development Bank.

You can rent a bike for €8.- per day at Willemstraatbike (Willemstraat 22) or for €18.- per day at Black Bikes (Vredenburg 29). See also: Bike rental in Utrecht.

#### **Public Transport**

For visitors to the Netherlands, OVpay is the best way to check in and out when travelling by public transport. One only needs a debit or credit card to easily travel throughout the country by train, tram, bus or metro. OVpay offers a direct connection between your ride and your bank account. It works just like cashless payments in the supermarket, with the difference that you also have to check out to calculate the fare. With the OVpay app you can monitor whether you have checked in during the trip and you can check your travel history. If you are visiting the conference, this

is the cheapest and most practical solution because you do not need a separate card and are not tied to an OV-chipkaart (€7,50). It is not possible to buy tickets using cash on the buses, you can only buy a ticket using a debit card or a credit card. A single run ticket is €3,10. Alternatively, single tickets can be bought with cash and any card at Utrecht Central Station, at the automatic vending machines or at the 'OV Service and Tickets' desk.

## Travel to Utrecht

We encourage participants to travel to Utrecht by train. Utrecht Central Station serves as a key railway junction in the Netherlands, offering frequent high-speed train connections to numerous European capitals, with some routes passing through Amsterdam Central Station.

For those traveling from further afield, Schiphol Airport in Amsterdam is the closest international airport. Direct train services are available from Schiphol Airport to Utrecht Central Station,
